4a (Code: ) (Expenses \$ 892,256. including grants of \$ 529,038. ) (Revenue \$ ) THE ONE FAMILY SCHOLARS PROGRAM (OFS) SUPPORTS SINGLE PARENTS WHO ARE EXPERIENCING OR AT RISK OF HOMELESSNESS, HELPING THEM TO GRADUATE FROM COLLEGE IN ORDER TO ACHIEVE CAREER AND HOUSING STABILITY. THE PROGRAM PROVIDES ONE-ON-ONE COACHING AND GUIDANCE ALONG WITH FLEXIBLE FINANCIAL AID, AND THE COMBINATION YIELDS INCREDIBLE RESULTS: ONE FAMILY SCHOLARS GRADUATE FROM COLLEGE AT A RATE OF 79%, COMPARED TO ONLY 28% FOR SINGLE MOTHERS NATIONWIDE. THIS LEADS TO LONG-TERM CAREER SUCCESS, ASSET-BUILDING, AND HOUSING STABILITY, AS EVIDENCED BY THE FACT THAT 91% OF OFS ALUMNI NOW HAVE SECURE HOUSING.

LOW-INCOME PARENTS ARE TOO OFTEN LEFT WITHOUT THE RESOURCES AND INFORMATION NEEDED TO ACCESS EDUCATION AND WORKFORCE OPPORTUNITIES. C2C FILLS THIS GAP. WE START BY IDENTIFYING EACH PARENT'S SKILLS AND INTERESTS, THEN ALIGN THEM WITH FAMILY-SUSTAINING CAREERS IN THE REGION. BY THE END OF THE INTENSIVE THREE-MONTH PROGRAM, EACH PARTICIPANT HAS A DETAILED PLAN TO OBTAIN ANY CREDENTIALS THEY NEED, AND TO USE THEM TO ENTER THEIR CHOSEN CAREER. ON AVERAGE, NEW JOBS SECURED THROUGH C2C LED TO AN INCOME INCREASE OF ALMOST \$19,000- NEARLY TRIPLING THE AVERAGE INCOME AT ENROLLMENT- WHICH CAN TRULY CHANGE A FAMILY'S FUTURE!
